Ways to give

There are different ways in which you can choose to support the Geological Society of London in your will. Your professional advisor may wish to use the following wording as a guideline:

For a share of your estate

Residuary legacy – this type of gift is popular because it takes care of family and friends first and remains proportional to the value of your estate by keeping pace with inflation:

"I give, to The Geological Society of London, a charity registered with the Charity Commission for England and Wales No. 210161, [insert specified percentage of residuary estate] to be applied to the [insert general purposes/preferred area] of The Geological Society of London and I declare that the receipt of the Director of Finance or other duly authorised officer of The Geological Society of London shall be good and sufficient discharge to my executors."

Amend an existing will

If you have an existing will and would like to add the Geological Society as a beneficiary, you may be able to do this by completing a codicil form. A codicil can be used in the case of minor changes, as a supplement to your existing will. It is essential that you speak to a professional advisor about introducing a codicil to your will.

For a specific amount

Pecuniary legacy – the value of this gift may decrease over time, as the cost of living increases:

"I give, to The Geological Society of London, a charity registered with the Charity Commission for England and Wales No. 210161, [insert a fixed amount] to be applied to the [insert general purposes/preferred area] of The Geological Society of London and I declare that the receipt of the Director of Finance or other duly authorised officer of The Geological Society of London shall be good and sufficient discharge to my executors."

Tax implications of making a gift in your will

If you leave a gift to charity in your will, the gift's value will not be counted towards inheritance tax. This could reduce the amount that your beneficiaries have to pay or remove your inheritance tax liability altogether.

In some circumstances, leaving 10% or more of a taxable estate to charity may result in a reduced rate of inheritance tax (36% rather than 40%). Please see **www.gov.uk/inheritance-tax** for further information.

Every gift, however large or small, makes a huge difference – even 1% (so those closest to you inherit 99%) or a modest sum of money will leave a lasting legacy.

You may choose to make a general donation, so that your gift can be directed to the area of greatest need, at the time it is used. Alternatively, if you are interested in supporting a specific part of our work we would be happy to discuss this with you.


