Instructions for Authors

ORAL PRESENTATIONS

Delegates are invited to submit no more than one abstract each as first author. Invited speakers will be allocated slots of 20 minutes' duration. Presentations by other contributing speakers will be allocated 15 minutes, including time for questions in all cases.

ABSTRACTS FOR ORAL PRESENTATIONS AND POSTERS

Each abstract may be up to 1 page of A4 (or US 'Letter') long. There should be a 2.5 cm margin on all sides of the page. *Please use an 11 pt Times New Roman font.*

Your abstract must include the following:

- Presentation title
- Author names (forename surname, 1,2,3, etc to indicate addresses and e-mail) Presenting author should be in bold type
- Address (of presenting author)
- ¹Author addresses (in full)
- Presenting author e-mail address
- Text
- You may include figures or tables (embedded in the text). Figure captions should be 9 pt Times New Roman font
- You may include a short list of references.

The following style should be used:

Title in sentence case, centred in 16 point bold

Presenting Author¹ bold 11 point text centred

Author² etc 11 point text centred

¹ *Author 1 address and email 10 point italic centred*

² *Author 2 address 10 point italic centred etc*

Text of the abstract should be in 11 point text and justified

Any references and figure captions should be given in 9 point text

Figures

Line diagrams and greyscale drawings must have a resolution of at least 600 dpi.

Photographs (halftones) must have a resolution of at least 300 dpi.

It is also possible to include colour diagrams in your abstract, but please note that in the paper abstract volume these will be printed in grayscale. (An electronic version of the abstract volume with colour diagrams and photos will be available from the conference website.)

Submission of abstracts

There are two means by which you can submit your abstract:

1. If you are using online registration, please attach the file for your abstract by clicking on the Browse button and locating the completed abstract on your computer's hard disk.
If you are not satisfied that this is the final version of your abstract, but wish to complete registration at this stage, please upload the current version of your abstract at any time before 4 July 2013. It will be possible to submit a revised abstract by emailing it to Kevin@minersoc.org, before 4 July 2013.
2. If you are using the paper registration form, please send the completed form to the Mineralogical Society office (as outlined on the form) and **e-mail** your abstract to kevin@minersoc.org as an attachment to an email.

PRESENTATIONS

Oral

For oral presentations, MS-Powerpoint is the preferred format.

Poster

Posters should be A0 portrait (84cm wide x 119cm high). There will be poster sessions on each of the three days of the meeting. Posters will remain up for one whole day and must be placed on the appropriate poster board as early as possible in the morning of the day assigned. Posters must be attended by authors during the dedicated poster session hours.
