### **CAREER ACHIEVEMENT AWARDS**

### THE WOLLASTON MEDAL

The highest award of the Geological Society. This medal is awarded to geologists who have *significant influence*, through *a substantial body of excellent research* in '*pure' and/or 'applied*' aspects of the science.

### THE LYELL MEDAL

Awarded to an individual who has made a *significant contribution* to the science by means of *a substantial body of research*. Those working in both 'pure' and 'applied' aspects of the geological sciences are eligible. The Lyell Medal is normally given for contributions to *soft rock* studies e.g. '*sedimentary rocks, processes and systems*'.

# THE MURCHISON MEDAL

Awarded to an individual who has made a *significant contribution* to the science by means of *a substantial body of research.* Those working in both 'pure' and 'applied' aspects of the geological sciences are eligible. The Murchison Medal is normally given for contributions to hard rock studies e.g. '*metamorphic and igneous rocks, processes and systems*'.







### **CAREER ACHIEVEMENT AWARDS**



### THE WILLIAM SMITH MEDAL

For *excellence* in contributions to *applied and economic aspects of geoscience*. Candidates will have made *significant contributions* to the application of geoscience. Other criteria may be used to support the nomination, should confidentiality be an issue. (Please see nonacademic nomination guidance).

### THE PRESTWICH MEDAL



This medal is awarded every three years for a *significant contribution* to the *advancement of the science of geology*.



#### THE SUE TYLER FRIEDMAN MEDAL

Awarded for the recording of the *history of geology.* The Medal, which can be awarded to *those without a geological background*, *of any nationality, and to non-Fellows of the Society*, is awarded at intervals determined by Council.

### **CAREER ACHIEVEMENT AWARDS**



## THE DEWEY MEDAL

This Medal is awarded for substantial and significant contributions to geology through sustained field mapping and/or field observation of rocks, and for a strong record of training, leading and encouraging others to practise and pursue advances in geology by these means.



#### **MID-CAREER AWARDS**

### THE BIGSBY MEDAL



Awarded biennially as an acknowledgement of *eminent services* in *any geological specialism*. Candidates must not have exceeded 25 years\* of a research career.



## THE ABERCONWAY MEDAL

Awarded biennially as an acknowledgement of *distinction in the practice of geology* with special reference to *work in industry*. Candidates must not have exceeded 25 years\* of a research career.

\*Full-time equivalent

### THE WOLLASTON, LYELL, MURCHISON AND WILLIAM SMITH FUNDS

Awarded to early career geoscientists who have made *excellent contributions* to geoscience research and its application, in the UK and internationally. Recipients must be within ten years of the award of their first degree in geoscience or a cognate subject.

The Wollaston, Lyell and Murchison Funds are awarded to contributors to the Earth Sciences based on *noteworthy published research*. The William Smith Fund is awarded for excellence in contributions to a*pplied and economic aspects* of geoscience.

The Funds are each accompanied by the award of £500.

## THE PRESIDENT'S AWARD

Up to two President's Awards are conferred annually upon early career geoscientists who are within eight years of the award of their first degree in geoscience or a cognate subject, who show *significant early promise* and are judged to have potential to be *future leaders in their fields*.

Awards are made annually at the discretion of the incumbent President.

The President's Awards have a value of £250 each.

### SERVICE AND/OR OUTREACH AWARDS

### THE COKE MEDALS

The two Coke Medals are named after Major John Sacheverell A'Deane Coke and Major Edward D'Ewes Fitzgerald Coke.

They are awarded to scientists for their *contributions to geology*, but recognition can also be given for *significant service to geology*, for example through administrative, organisational or promotional activities *resulting in benefits to the community*.

The award can be extended to scientists whose training and interests are outside the main fields of Geology, whose contributions are of great significance to our science.





#### THE DISTINGUISHED SERVICE AWARD

This award is made annually to an individual/s who has made a *significant contribution* to geoscience and the geoscience community by virtue of their *professional, administrative, organisational or promotional activities*.

### THE R.H. WORTH AWARD

Awarded in recognition of achievements in *outreach, public engagement and/or education* of an individual or an institution.





#### **NOMINATION GUIDANCE**

# **ELIGIBILITY**

• You **do not** have to be a Fellow of the Geological Society of London to be nominated for our prizes and awards, but you **do** have to be a Fellow to submit a nomination.

• In addition, some awards have eligibility restrictions. Please check the criteria carefully for the award you wish to make a nomination for.

- Nominees may be of any nationality and/or geographical location.
- There is no cost associated with the nomination process.

### **CAREER STAGE CRITERIA**

• It is recognised that the work of the nominees may not be widely known in the case of the William Smith Medal and the Aberconway Medal, so an exception can be made that **the proposer should be from a different institution** but **the seconder can be from the same institution** as the nominee.

• In the case of nominations for the Lyell, Murchison, William Smith and Wollaston Funds where it is also recognised that the work of the nominees may not be widely known, **the proposer may be at the same institution** but **the seconder must be from a different institution**.

• Fund nominees should ideally be within ten years (full time equivalent) of the award their first degree in geoscience or a cognate subject. If the person nominated appears not to meet this requirement, please explain on the nomination form in the space "Date of award of first degree or commencement of research career whichever is the later". Career breaks due to maternity/paternity leave are taken into account. Additional allowance may be made for other known career breaks.

### **SUBMITTING A NOMINATION**

• Fill in the nomination e-form available at *www.geolsoc.org.uk/About/Awards-Grants-and-Bursaries* and return electronically to *awards@geolsoc.org.uk*.

• A proposer and a seconder is required for each nomination. See note below regarding Specialist Group nominations.

• Proposers are encouraged to submit statements that directly address how the nominee fits the remit of the Medal or Award they are being put forward for.

• The proposer must be a Fellow and it is preferable, although not essential, for the seconder also to be a Fellow.

• The proposer and seconder must not be from the same institution as the nominee. (See the career stage criteria on page 10 for some exceptions.)

**Note:** For nominations by Specialist Groups, the proposer is the Specialist Group so the details of its President/Chair should be provided

### **GENERAL INFORMATION**

• All sections of the nomination e-form must be completed including the brief statement of **no more than 100 words** stating why the nominee merits a Society Award. This section is character limited.

- The e-form sections must not exceed character limits set. Attachments will not be considered.
- E-forms must be submitted electronically.
- The e-form must include proposer/seconder names, be dated and contact emails provided. For nominations from a Specialist Group, the proposer and seconder can be the Chair, Secretary, Treasurer or similar.

For those wishing to nominate an individual from industry or government. Please see the separate guidance notes on 'Additional Guidance for Non-Academic Candidates'. Note: Nominations are treated as confidential.

Nominations put forward by Specialist Groups only require the name and email details of the Chair/ President of the Specialist Group. This nomination must include the name of the Specialist Group on whose behalf the nomination is made.

The Awards Committee relies on the proposers to check the accuracy of the supporting information. By naming, dating and providing emails on the nomination form, the proposers are confirming that, to the best of their knowledge, the details given in support of a nomination for an award are accurate.

This is a competitive process and to avoid potential disappointment please do not inform the nominee that they are being nominated for a Society award.

The Awards genereally are conferred at a ceremony held at Burlington House usually on the same day as the Society's Annual General Meeting.

### NON-ACADEMIC NOMINATION GUIDANCE

Please use these additional guidance notes to help you nominate a nonacademic candidate for one of our Awards. Note: the information in the nomination form will be treated as confidential.

### **EVIDENCE OF IMPACT**

Evidence, either through career progression or tangible legacy, that the nominee has been and remains technically engaged in the use and development of the Earth Sciences and the building of capability. For example, by creating value individually or through teams. Specific examples could be:

• In extractive industry: evidence of business success measured in the areas of business development, exploration, production and sustainability.

• In engineering or hydro-geology, business success measured through association with major or innovative projects with sustainable benefit.

• In the public sector (e.g. Environment Agency, British Geological Survey), success measured in the areas of public impact and scientific legacy

## **EVIDENCE OF PERSONAL LEADERSHIP**

 Progression of a geological career including evidence of personal and scientific leadership, relationship building, team building, innovation, people coaching and development, leading and implementing organisational change,

### NON-ACADEMIC NOMINATION GUIDANCE

### **EVIDENCE OF SERVICE TO INTERNATIONAL** & NATIONAL GEOSCIENCE COMMUNITY

- Service to professional bodies, e.g. Societies, Conferences, National Peer Review Bodies, Boards and Advisory Groups, lecture tours,
- Publication legacy of international peer reviewed papers.
- Support of outreach to educate and engage new generations of Geoscientists.

## **EVIDENCE OF PERSONAL VALUES**

These values are equally applicable to all candidates, including those of academic background.

- Ethics in work and personal life in line with the Nolan Principles .
- Championing diversity, inclusion, and people development.
- Conscious of sustainability and impact.
- Service to community and society.
